影響の要因

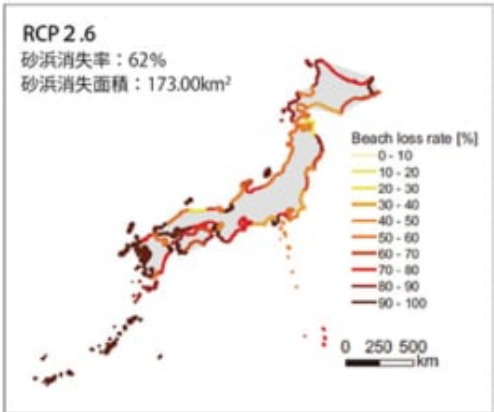
気候変動による海面水位の上昇や台風の強度増加に伴う荒天時の波高増加は、砂浜の形状や面積に影響を及ぼす。



現在の状況と将来予測

1980年代以降日本沿岸で海面水位の上昇が観測されているが、海岸侵食への影響については、その他の要因の影響も踏まえて明らかにする必要がある。

将来、気候変動による海面水位の上昇によって、海岸が侵食される可能性が高い。海面上昇に起因する日本の沿岸地帯における将来の砂浜消失率を予測した研究結果（Udo and Takeda 2017）では、21世紀末（2081～2100 年）までに、RCP2.6で62%、RCP4.5で71%減少する予測が示されている（右図参照）。

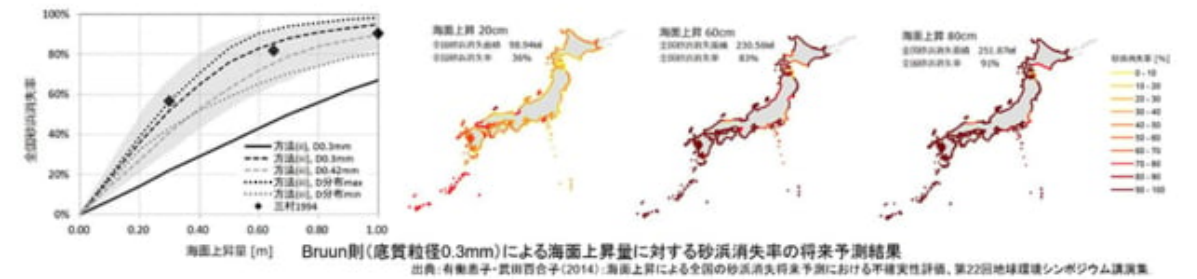

- 気候変動による影響により、海面水位の上昇、強い台風の増加に伴う波浪と高潮の増大の影響が予測される。これにより、海浜の減少が想定される。(再掲)
- 海岸保全施設前面の海浜の減少により、海岸保全施設に作用する波力や洗掘量が増大し、被災の可能性が大きくなる。(再掲)
- 有働・武田(2014)によれば、Bruun則による砂浜消失率の予測結果では、20cmの海面上昇で36%、60cmの海面上昇で83%、80cmの海面上昇で91%の砂浜が消失する。

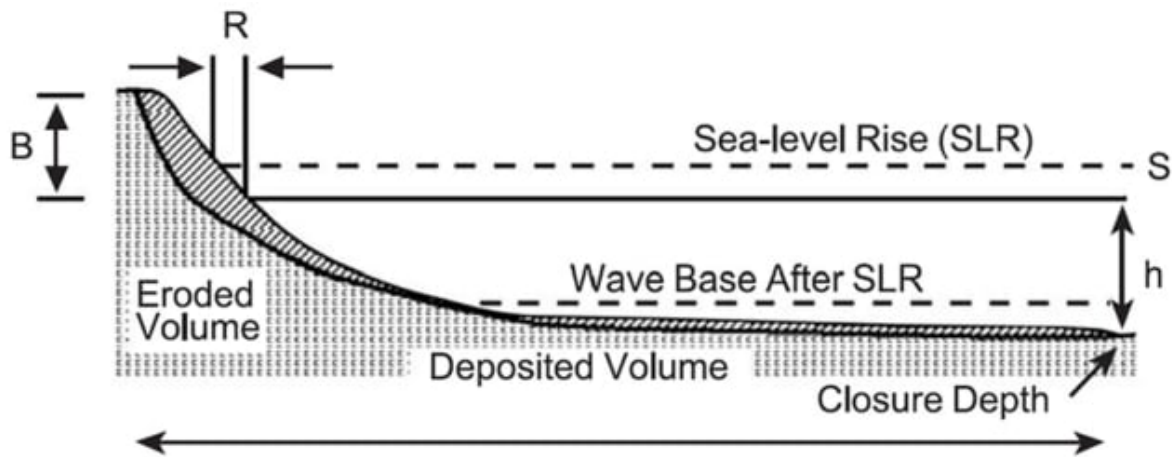

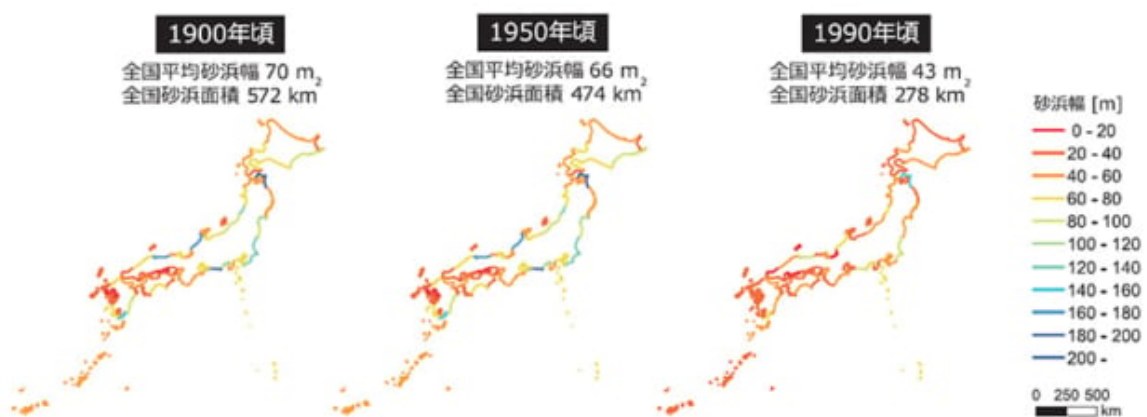


Fig. 1 Average beach widths at around 1900, 1950, and 1990 in 77 coastal zones in Japan.
